EDGE Rotorblades ("EDGE") warrants to the original end user customer of its products specified below that its products are free from defects in material and workmanship. Subject to the conditions and limitations set forth below, EDGE will, at its option replace its products that prove defective by reason of improper workmanship or materials, replacement products will be provided by EDGE on an exchange basis. This limited warranty does not cover any damage to this product that results from improper installation, accident, abuse, misuse, or any unauthorized repair, or modification.

Duration of Warranty

1 year Warranty:

The following EDGE products are covered by this warranty for a period of one year from the date of original retail purchase: All main blades, tail blades and paddles.

Conditions

- Cosmetically Flawed Product

Main blades, tail blades and paddles with cosmetic flaws, such as imperfections in the finish, i.e. gel coat blemishes, dents or scratches should be returned unused. Mounting and/or flying cosmetically flawed blades will automatically void their warranty.

- Defective Product

Main blades and tail blades found to have defects in workmanship caused by an imbalance of CG resulting in the inability of the blade to track can be returned for an exchange.

This limited warranty applies only to the original end user customer of the product for so long as the original end user customer owns the product. This limited warranty is non-transferable.

Warranty Claim Procedures and Requirements

To obtain warranty service, you may return the defective product to an authorized EDGE dealer or distributor from which you purchased the EDGE product. Please confirm the terms of your dealer's or distributor's return policies prior to returning the product. Typically, you must include product identification information; including blade size and type with a detailed description of the problem you are experiencing. You must also include proof of the date of original retail purchase as evidence that the product is within the applicable warranty period.
